The KVB is seeking nominations for candidates to run for four (4) vacancies available on the 2008 KVB Board of Directors. Terms are as follows:

Three (3) three-year Terms	expiring December 31, 2010
One (1) two-year Term	expiring December 31, 1009

Article 4.0 of the KVB Bylaws, Board of Directors, states:

“The Board of Directors will be the governing body of the corporation, will manage the corporation’s business, and will exercise all of its powers except where the same would conflict with the Articles of Incorporation or these Bylaws.”

Candidates for board office must be:

- ◆ An employee of a KVB member organization or an individual member, in good standing (dues paid through 2007-2008 membership year, and no outstanding bills owed to the organization for services);
- ◆ Able to commit their time and energy to advance the goals of the KVB. Board members are expected to attend monthly meetings (held the 4th Tuesday of each month, at 5:30pm) and if elected to serve on the board’s executive committee, will attend its meetings (presently 2nd Tuesday of each month).
- ◆ Willing to assist with committee work, serving on at least one committee of their choice.

To nominate a KVB member to run for election, please fill out the attached nomination form and return it to the KVB office. The deadline for nominations is 5:00pm, Friday, September 21, 2007. Nominees must provide a short biography for inclusion in the KVB ballot to be sent to members. For more information, please contact the Ketchikan Visitors Bureau at 225-6166.
